About this Manual

The purpose of this document is to help the citizens in operating the Trade License System (TLS). It provides a digital interface, allowing citizens to apply for the Trade License and subsequently make the payment online.

The TLS allows the citizens to:

- Apply for a Trade License
- Complete the Payment for Trade License
- Keep a track of the status of the Trade License
- Download receipts of the payments made for any TL
- Maintain a personal profile.

This manual covers up the various features of TLS and every feature is defined with a screenshot for user assistance.


1.General Functions

Following are the general functions of the application:


1.1 Login into the application

On the login page the citizen enters the details(name, mobile no., city)




1.2. Editing the Profile

- Capture/update email ID


1.3. Updating name, mobile number and email id

Two options appear on the screen: 'Gallery' and 'Remove'



2.1Applying for a new Trade License


Citizen logs into the system and sees the Landing page with option Trade License. User clicks on 'Trade License'







Once the citizen selects the city a form for applying for trade license would open up as shown below









Once the citizen has uploaded the documents, the next step is the summary of the filled application form as shown below.




3. Payment of License fee

Once the application is approved by the Approver, Citizen can pay the license fee in 2 ways:

- 1)Self payment by logging and then searching for his application.
- 2)At the ULB counter.

Self Payment Mode


Citizen searches for his application and then he lands on the below screen:


The citizen goes to the ULB counter, makes the payment and gets his certificate in the above mentioned format

4. Renewal of Application

The renewal of application is a process by which a citizen can get his/her license renewed for the next financial year(s).

There are 2 ways for doing the same:

1) If the license issued earlier was not processed by the system, then the user has to go through the same process for new application as directed above with one change:




The rest of the process remains the same as for the new application.

2.If the earlier license issued was system processed/issued then follow the below steps:


<u>Step 1</u>:The citizen logins to the same portal as for the new application on the link https://mseva.bihar.gov.in/citizen/ and then enter the Trade License and lands on the below page:



<u>Step2</u>: The page opened shows you all the applications sent by your mobile number.



Step3:Then the application opens up.



There are 2 options:

- 1) <u>EDIT</u>: if there is some information that has to be changed in the application and then application has to be resubmitted. This option would ask you to go through the full process again as the same for new.
- 2) <u>Submit for Renewal:</u> If there is no change in the application information provided earlier then the employer can submit the application for renewal and collect payment in a similar fashion as for the new application(as stated in step 4 of new application submission).
