(Under Rule 20 of the Cantonment Electoral Rules, 2007)

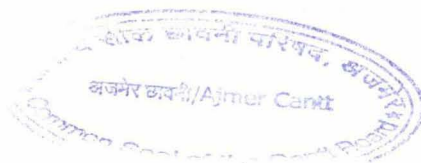
WHEREAS, the Central Government, in exercise of powers conferred under section 15(1) of the Cantonments Act, 2006, has vide Gazette Notification SRO 3 (E) dated 17.02.2023, notified 30.04.2023 as the date on which election to Cantonment Board, Ajmer shall be held.

NOW the Cantonment Board, Ajmer, in pursuance of the said Gazette Notification SRO No. 3(E) dated 17.02.2023 of the Central Government, under the provisions of Rule 20 of the Cantonment Electoral Rules, 2007 sets out hereunder: -

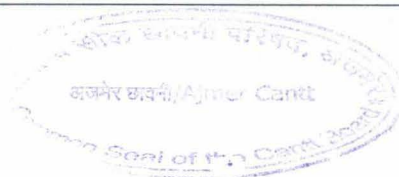

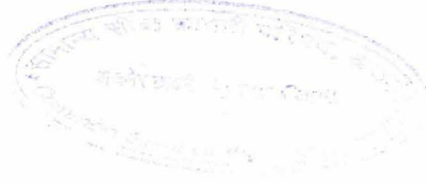

- c) The symbols that may be chosen by candidates and the restrictions to which their choice shall be subject shall be in accordance with the Election Symbols (Reservation and Allotment) Order, 1968 of the Election Commission of India, as modified from time to time till date and the Notifications of the Election Commission of India issued in pursuance of the said orders, as amended from time to time till date, and the allotment of symbols by the Returning Officer shall be governed by the provisions of Rule 31(4 and 5) of the Cantonment Electoral Rules, 2007 and instructions contained in Government of India, Ministry of Defence (ML&C Dte) letter No. 29/3/C/L&C/67 dated 30.11.1973.



- (d) The nomination papers will be presented to the Returning Officer in the Cantonment Board Office, Ajmer on the date and time fixed above.
- (e) The Scrutiny and hearing of objections, if any on the Nomination papers will be held in the office of the Cantonment Board, Ajmer on the date, time and place mentioned above.
- (f) Nomination papers may be obtained from the office of the Cantonment Board, Ajmer during working hours on any working day. Form of application for inclusion of names in the electoral rolls can be obtained from the office of the Cantonment Board, Ajmer during the time prescribed above.
- (g) Each candidate with his nomination paper shall deposit or cause to be deposited to the Returning Officer **Rs. 3000/- (Rupees Three Thousand only) in Cash**. Provided that where the candidate belongs to Schedule caste or Schedule Tribe the amount of such deposit shall be rupees **Rs. 1500/- (Rupees One Thousand Five Hundred only) in Cash**. Provided that where more than one nomination paper is presented, one deposit only shall be sufficient.
